SUMMER PROGRAMS

Wasatch Adaptive Sports provided 2,072 experiences in cycling, mountain biking, paddling, and yoga to 464 students with adaptive needs and their support network. In the summer program survey, students reported experiencing increased strength (91% of respondents), increased independence in recreation (94%) and day-to-day life (82%), improved self-esteem (97%), increased motivation to be active (94%), and improved quality of life (94%) due to summer program engagement.

WINTER PROGRAMS

Across both winter and summer sessions, Wasatch Adaptive Sports delivered a 52% increase in individuals over the prior year. Wasatch Adaptive Sports provided over 1,942 experiences in skiing and snowboarding, indoor cycling, yoga, and snowshoeing experiences to 466 students with adaptive needs. In the survey disseminated to students who participated in the 2021-22 winter programs, respondents reported improvements in overall mental health (89% of respondents), physical health (93%), quality of life (93%), and motivation to be active (93%) as a result of program engagement.
